After I found A.A. and stopped drinking, it took a while before I understood why the First Step contained two parts: Practicing the A.A. program is like building a house. First I had to pour a big, thick concrete slab on which to erect the house; that, to me, was the equivalent of stopping drinking. But it’s pretty uncomfortable living on a concrete slab, unprotected and exposed to the heat, cold, wind and rain. So I built a room on the slab by starting to practice the program. The first room was rickety because I wasn’t used to the work. But as time passed, as I practiced the program, I learned to build better rooms. The more I practiced, and the more I built, the more comfortable, and happy, was the home I now have to live in.

24 Diverter

Monthly service opportunities are always changing and coming available; to volunteer or for more information please call Fred R. at 466-9350 or 247-1405. Diverter Training is done on the 3rd Wednesday of every month, 6:00 pm to 7:00 pm, at the Central Office.

Public Information/Cooperating with The Professional Community (PI/CPC)

Bridging the Gap (BTG)

BTG needs committee members. BTG delivers presentations at recovery centers and correctional facilities.

The hour-long presentation entails explaining Bridging the Gap, and sharing personal experience, strength, and hope.

Our goal is to have at least two committee members give the presentation, a new committee member will not be expected to deliver a presentation by themselves. Sobriety requirement is three months. Committee member meetings are held ad hoc at Central Office. Contact Mac B. at 831-238-4887 for more information.

Hospitals and Institutions (H&I)

Interested in being of service? H & I has lots of service positions available. Si Se Puede is in need of volunteers with six months of sobriety, Spanish not required. Mondanaro-Baskin Center is looking for female volunteers with at least six months of sobriety. Juvenile Hall is also in need of Secretaries. The requirements are one year of sobriety, must be 18 or older, and not be on probation or parole. If anyone is interested in service work at any of the jails in Santa Cruz County they are all in need of help. You must attend an orientation, which is held the last Wednesday of each month, at the Main Jail Facility, 259 Water Street, Santa Cruz, CA, 95060. Blaine Street Women's Jail has a sobriety requirement of two years and you must be female. Water Street Jail Men's Facility requires three years of sobriety, five years since your last felony, and that you are not on parole or probation. To serve at the Water Street Jail Women's Facility you must be female with at least three years of sobriety and not be on parole or probation. The Watsonville Farm is looking for a male Secretary with three years of sobriety who is not on parole or probation.
